**AMENDMENT AND EXTENSION OF DECLARATION OF
THE CITY OF DILLEY, TEXAS, DECLARING A LOCAL
STATE OF DISASTER AND PUBLIC HEALTH
EMERGENCY**

WHEREAS, the City of DILLEY on the 9th day of March, 2021, has determined that there is an imminent threat of injury or loss of life or property resulting from:

The novel coronavirus (COVID-19) has been recognized globally as a contagious respiratory virus and due the Executive Order GA -34 issued by the Governor of the State of Texas effective March 10, 2021,

WHEREAS, the City Council of DILLEY has determined that extraordinary measures must be taken to alleviate and prevent the suffering of people and to protect property; and

NOW, THEREFORE, AMENDS AND EXTENDS AND BE IT PROCLAIMED, BY THE CITY COUNCIL OF DILLEY:

That a local state of disaster is hereby declared for DILLEY pursuant to Section 418.108(a) of the Texas Government Code.

Pursuant to Section 418.108(b) of the Texas Government Code, the state of disaster shall continue for a period of 30 days from the date of this declaration unless continued or renewed by the City Council of the City of DILLEY.

Pursuant to Section 418.108(d) of the Texas Government Code, this declaration of a local state of disaster shall be given prompt and general publicity and shall be filed promptly with the City Secretary.

Pursuant to Section 418.108(d) of the Texas Government Code, this declaration of a local state of disaster activates the city emergency management plan.

Pursuant to Section 122.006 of the Health and Safety Code, That this declaration authorizes the City to take any actions necessary to promote health and suppress the virus, including the quarantine of persons and occupied structures, examining and regulating hospitals, regulating ingress and egress from the City, regulating ingress and egress to occupied structures, establishment of quarantine stations, emergency hospitals, and other hospitals, and insuring compliance for those who do not comply with the City's rules,


- 1. City of Dilley Buildings and Facilities. It is ordered as follows: Masks or face coverings are required to be worn in all City owned buildings and facilities by employees and members of the public entering the City buildings, to include Dilley City Hall and City Hall Lobby, Dilley Public Library, Police Department Lobby, Dilley Municipal Court.**


2. The City Park playground equipment, baseball fields & basketball courts shall be open but subject to social distancing and masks or face coverings will be required on all city owned properties until further notice.

3. **Daytime Curfew.** This declaration hereby implements a citywide daytime curfew for all school age children and juveniles that directly prohibits school age children and juveniles from being out in public places inside the city limits between the hours of 8:00 a.m. and 4:00 p.m. daily during the duration of this declaration until or unless amended by the City Council. Exception to this curfew includes travel to and from a wifi zone or hotspot in order to complete online school or to and from work/place of employment, and medical facilities, and for the week of Spring Break and other School Observed Holidays.

That this proclamation shall take effect immediately from and after its approval by the City Council of the City of DILLEY and shall remain in effect for the next 30 days, unless revoked or extended by City Council of the City of DILLEY.
