Presentation done by Mr. Vela, has been working on study for a 1 year, did his best to try and work with the citizens of the community, has come With a water rate proposal#1-in which a rate increase for water and sewer services will be needed for the city to meet its anticipated debt obligations, operate and maintain its water system and implement needed capital repairs, replacements and improvements. Residential rates-\$22.66 with 3,000 gallons and \$5.02 per 1,000 gallon after that. Outside residential rate-\$38.66 with 0 gallons Bulk water - \$78.03/ 0 gallons/\$26.01 per 1,000 gallons. Sewer proposed charge for 4,500 gallons of usage residential meter-\$32.42

Council and staff worked to see how the comparison of the proposed rates met the current rates.
