CITIZENS TO BE HEARD Oneida Segovia had a complaint against the police department, stating that she was being harassed by the Police Dept, she stated her vehicle was searched and they never told her why they were searching, she stated that drugs were found and that it was not hers because she had cleaned her car that morning.

Amy Hernandez, wanting to know why the facebook page for the police department was taken down, if she stated they were doing a good job, she further stated that the city where she came from had a facebook page and it was a good way to hold criminals accountable for their actions so she didn't understand why the page was taken down.

Michelle Stephenson was complaining against the Police Dept. She stated that she had been pulled over by the PD and that they stated she had an expired registration and she gave them proof that it wasn't expired, then asked her for permission to search her car and she stated no because there was no probable cause and she stated that she got arrested.

Chief Romo informed council that his department was in desperate need of equipment.

Premier Engineering was E Tech Construction, Inc. Bid was in the amount of \$32,000. Premier informed council that they had not done work with E Tech but Jimmy Oranday Public Works Director has worked with them in previous city. City Administrator Juan Estrada informed council that by having an appointed Public Relations Officer, it would be best for media communication. This person would communicate directly with all media. Departments would meet with Officer prior to releasing statements to the Media. Denise Martinez (substitute for Mr. Maldonado) informed council that other cities have an appointed Public Relations Officer so that accurate statements are released to the media. Council would like to review more information regarding duties of an appointed public relations officer.
