- 6. DISCUSS/CONSIDER & ACT ON NATIONAL NIGHT OUT PRESENTATION Mrs. Ana Aguilar, Police Secretary informed city council of the process to prepare for the National Night Out event, she stated that the event would take place on October 1, 2019. 7. DISCUSS/CONSIDER & ACT ON SAFETY RESOURCE OFFICER
Interim City Admin David Jordan informed city council that the school had
approached the city to entertain the idea of a Security Resource Officer. He stated
that the proposal was for the city and school to pay 50/50 percentages and the SRO

would be employed by the city and staffed at the school during the school year, once school year ended SRO would then work for the city as a regular patrolman. Motion made by Council Member Place 5 Joe Garcia to approve the proposal for a Security Resource Officer and to have City Attorney draw up contract with requirements as to how the position would function and to incorporate into the contract the 50/50 percentage by both the City & School District Motion seconded by Council Member Place 2 Joanne Rodriguez All in favor Motion carries unanimously

8. DISCUSS/CONSIDER & ACT ON ADOPTING A HIRING & SEPARATION OF EMPLOYMENT POLICY

Human Resources Manager Raquel Yanez explained the policy to city council stating that she had sent out the copies for review three or four weeks prior to the meeting. Mayor Obregon asked if council had any questions and no questions were asked.

9. DISCUSS/CONSIDER & ACT ON ADOPTING ORDINANCE NO. 19-06-25, AN ORDINANCE OF THE CITY OF DILLEY, TEXAS BY WAIVING LATE FEE PENALTIES ON PUBLIC UTILITY SERVICES RECONNECTION FEE TO ELIGIBLE ELDERLY RESIDENTIAL CUSTOMERS, BY PROVIDING SAVINGS, CUMULATIVE REPEALER AND SEVERABILITY CLAUSES; AND BY PROVIDING AN EFFECTIVE DATE

Council Member Place 5 Joe Garcia informed city council that this item was placed on agenda as per his request, he felt that if elderly citizens didn't make payment on the account it was because they didn't have the funds and waiving the reconnect fee would help them. Council expressed that they agreed with the ordinance but wanted to limit the account to just the primary account. City Secretary suggested that language be added to the ordinance to limit the applications to just one account because currently the ordinance did not state a limit. Mr. Maldonado stated that city staff could make that determination. Mrs. Machado questioned the process asking if they were delinquent would they still be disconnected, and City Secretary replied that the process would still be followed if the account was delinquent, they would still have to make payment, however the reconnect fee would be waived when reinstating.

Motion made by Mayor Pro-tem Everardo Castillo, Jr. to adopt Ordinance No. 19-06-25 as presented to include that only one account, the Primary residential account

could apply for the waiver and for Ordinance to become effective after its publication as required

#### 14. DISCUSS/CONSIDER & ACT ON HWY 85 CONSTRUCTION

Mr. Raymond Quigg with Anderson Columbia (ACCI) gave city council a presentation of the two phases of construction he had bided on and had been awarded. He informed city council of the traffic being rerouted to avoid heavy traffic on city streets. The only city streets affected on the east side of town would be South Commerce by the Pitstop and E Harris from Dilley Feed to Hwy 81 S. He also informed city council that any damages to city streets would be paid by Anderson Columbia (ACCI). A letter would be generated and sent to Mr. Jordan to be kept on file in the event there were any damages.

Motion made by Council Member Place 3 Alicia Machado to approve the Hwy 85 Construction with changes made to the detour route as stated and letter to be filed with Mr. Jordan confirming ACCI would be responsible for any damages on city streets
