3. Pledges of Allegiance to the United States and Texas Flags


Texas Pledge: "Honor the Texas Flag; I pledge allegiance to thee, Texas, one state under God, one and indivisible."

This is the opportunity for citizens, visitors and guests to address the City Council on any issue or any item of the agenda, in compliance with LGC Section 551.007. City Council may not discuss any presented issue, nor may any action be taken on any issue at this time. Citizens to be heard are limited to three (3) minutes each. (Attorney General Opinion – JC-0169)
6. Discuss/consider & act on Interlocal Cooperation Agreement between Dilley Independent School District and the City of Dilley for purposes of staffing two (2) School Resource Officers
7. Discuss/consider & act on postponing the October 11, 2022 Regular Meeting to a special meeting on October 18, 2022 due to the TML Annual Conference
8. Discuss/consider & act on approval to close bank accounts with First State Bank, Louise as they are zeroed out and transferred to the pooled account
