## RESOLUTION NO. 23-05-15

### A RESOLUTION CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE MAY 6, 2023, GENERAL ELECTION OF THE CITY OF DILLEY, TEXAS

**WHEREAS**, the City Council of the City of Dilley, Texas (City) held a General Election on May 6, 2023 for the purpose of electing one Mayor and two Council Members to the Dilley City Council for a two-year term, specifically Mayor and City Council Places 1, and 2 and:

**WHEREAS**, the names of the candidates were submitted, the election was held and conducted and the returns thereof were made, all as required by laws of the United States and the State of Texas, including particularly the Texas Election Code; together with all amendments and additions thereto; and

**WHEREAS**, it was found that the persons herein named received the following votes for said term of office on the Dilley City Council of the City of Dilley, Texas; and

**WHEREAS**, pursuant to the Texas Election Code, the City Council of the City of DILLEY, Texas, convened on this the 15<sup>th</sup> day of May, 2023 at 6:30 P.M. for the purpose of canvassing the vote in the general elections held on May 6, 2023;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DILLEY, TEXAS, THAT:

#### **Section One. Canvass of Vote - General Election.**

(a) There came to be considered the returns of the general election held on the 6<sup>th</sup> day of May 2023, for the purpose of electing the Mayor and Councilmembers for Place 1, and 2, and it appearing from said returns, duly and legally made; that each of the candidates in said election received the following votes:


