## RESOLUTION NO. 24-05-14

### A RESOLUTION CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE MAY 4, 2024, GENERAL ELECTION OF THE CITY OF DILLEY, TEXAS

**WHEREAS**, the City Council of the City of Dilley, Texas (City) held a General Election on May 4, 2024 for the purpose of electing three Council Members to the Dilley City Council for a two-year term, specifically City Council Places 3, 4, and 5;

**WHEREAS**, the names of the candidates were submitted, the election was held and conducted and the returns thereof were made, all as required by laws of the United States and the State of Texas, including particularly the Texas Election Code; together with all amendments and additions thereto; and

**WHEREAS**, it was that the persons herein named received the following votes for said term of office on the Dilley City Council of the City of Dilley, Texas; and

**WHEREAS**, pursuant to the Texas Election Code, the City Council of the City of Dilley, Texas, convened on this the 14<sup>th</sup> day of May, 2024 at 6:30 P.M. for the purpose of canvassing the vote in the general Elections held on May 4, 2024;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DILLEY, TEXAS, THAT:

#### **Section One. Canvass of Vote-General Election.**

- (a) There came to be considered the returns of the general election held on the 4<sup>th</sup> day of May 2024, for the purpose of electing the Council members for Place 3, 4 and 5, and it appearing from said returns, duly and legally made; that each of the candidates in said election received the following votes:



**Section Two.** Filing with the Secretary of State. The City Secretary is hereby directed to do and perform the tasks and responsibilities necessary and required by the Secretary of the State of Texas.

**Section Three.** If any part or parts of this resolution are found to be invalid or unconstitutional by a court having competent jurisdiction, then such invalidity or unconstitutionality shall not affect the remaining parts hereof and such remaining parts shall remain in full force and effect, and to that extent this resolution is considered severable.

**Section Four.** This Resolution will become effective immediately upon its passage by the Dilley City Council.
