## ORDINANCE NO. 24-03-12-B

**AN ORDINANCE REPEALING ORDINANCE NO. 06-11-20 AND CREATING AN EXCLUSIVE FRANCHISE AGREEMENT WITHIN THE CITY OF DILLEY WITH BFI WASTE SERVICES OF TEXAS, L.P., DBA REPUBLIC SERVICES OF SAN ANTONIO A TEXAS, LP FOR THE COLLECTION, HAULING AND DISPOSAL OF OF RESIDENTIAL, COMMERCIAL AND INDUSTRIAL SOLID WASTE; AUTHORIZING THE CITY ADMINISTRATOR OF THE CITY OF DILLEY TO EXECUTE DOCUMENTS FOR THE CONTRACT AND TO ESTABLISH AN EFFECTIVE DATE.**

**WHEREAS**, the City Council desires to enter a new agreement on April 1, 2024 with BFI Waste Services of Texas, L.P., dba Republic Services of San Antonio a Texas Limited Partnership, (the "Franchise Contract"); and

**WHEREAS**, the City Council of the City of Dilley has determined that such contract is necessary to preserve or protect the public health of the citizens of Dilley, Frio County, Texas.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DILLEY, TEXAS, THAT:**

**SECTION 1. Agreement:** The City Council approves and authorizes the agreement of the Franchise Contract to BFI Waste Services of Texas, LP d/b/a Republic Services.

- a. The Franchise Contract will be effective April 1, 2024.
- b. A 10% administrative charge will be assessed to each garbage account.
- c. Residential & Commercial accounts outside the city limits will constitute a charge of 150% of total garbage bill.
- d. The City Administrator is authorized to execute such documents reasonably necessary to effectuate formal agreement of the Franchise Contract in Exhibit A Mutual Materials Management Agreement.

**SECTION 2. Incorporation of Recitals.** The City Council finds the recitals in the preamble of this Ordinance are true and correct and incorporates them as findings of fact

**SECTION 3. Severability:** If any portion of this Ordinance shall, for any reason, be declared invalid, invalidity shall not affect the remaining provisions thereof.

**SECTION 4. Repealed:** All Ordinances, parts of Ordinances or Resolutions in conflict herewith are expressly repealed.




**SECTION 5. EFFECTIVE DATE.** This ordinance shall become effective upon adoption of this ordinance.
