

**ORDINANCE NO. 19-04-09**

**AN ORDINANCE OF THE CITY OF DILLEY, TEXAS ADOPTING THE 2018 EDITIONS OF THE NATIONAL ELECTRICAL CODE, INTERNATIONAL BUILDING CODE, INTERNATIONAL RESIDENTIAL CODE, INTERNATIONAL FIRE CODE, INTERNATIONAL PLUMBING CODE, INTERNATIONAL MECHANICAL CODE, AND INTERNATIONAL ENERGY CONSERVATION CODE; AMENDING THE CODE OF ORDINANCES; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING A PENALTY CLAUSE.**

**WHEREAS**, the City Council of the City of Dilley, Texas desires to adopt the 2018 Edition of the National Electrical Code, as amended, the 2018 Edition of the International Building Code, as amended, 2018 Edition of the International Residential Code, as amended, 2018 Edition of the International Fire Code, as amended, 2018 Edition of the International Plumbing Code, as amended, 2018 Edition of the International Mechanical Code, as amended, and the 2018 Edition of the International Energy Conservation Code, as amended in order to protect citizens and visitors to Dilley and for the general public health, safety, and welfare;

**NOW THEREFORE: BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DILLEY:**

**Sec. 1. - Codes Adopted.**

The following codes are hereby adopted by the City of Dilley:

- a. 2018 Edition of the National Electrical Code, as amended.
- b. 2018 Edition of the International Building Code, as amended.
- c. 2018 Edition of the International Residential Code, as amended.
- d. 2018 Edition of the International Fire Code, as amended.
- e. 2018 Edition of the International Plumbing Code, as amended.
- f. 2018 Edition of the International Mechanical Code, as amended.
- g. 2018 Edition of the International Energy Conservation Code, as amended.

**Sec. 2. - Enforcement.**

The duly constituted authorities of the city and others having the duty of enforcing the ordinances of the city are hereby authorized to enforce all of the adopted codes.

**Sec. 3. - Fees and Charges.**

That all current fees and charges, as amended, shall apply to the adoption of these codes and those authorities of the city and others having the duty of implementing and enforcing the ordinances of the city are hereby authorized to collect all of the adopted fees and charges.

**Sec. 4. - Penalty.**

Any person who shall violate any provision of this ordinance shall, upon conviction, be punished by a fine or not more than five hundred dollars (\$500.00).

**Sec. 5. – Code of Ordinances.**

The Code of Ordinances of the City of Dilley, Texas, as amended, will remain in full force and effect, save and except as amended by this ordinance.

**Sec. 6. - Severability.**

Should any article, section, part, paragraph, sentence, phrase, clause or phrase of this ordinance, for any reason, be held illegal, inoperative, or invalid, or if any exception to or limitation upon any general provision herein contained be held to be unconstitutional or invalid or ineffective, the remainder shall, nevertheless, stand effective and valid as if it had been enacted and ordained without the portion held to be unconstitutional or invalid or ineffective.


**Sec. 7. - Publication.**
