

ORDINANCE NO. 15-04-14

AN ORDINANCE OF THE CITY OF DILLEY, TEXAS (CITY) AMENDING **ORDINANCE NO. 11-12-13** ADOPTING NEW UTILITY RATES FOR NATURAL GAS, WATER AND SEWER, INCLUDING NEW GENERAL SERVICE, DEPOSIT, TAPPING, AND LINE EXTENSION; IMPLEMENTING A METER-SIZE BASED MINIMUM CHARGE STRUCTURE FOR WATER SERVICE; INCREASING MINIMUM CHARGES AND VOLUMETRIC RATES EACH YEAR FROM OCTOBER 2014 THROUGH OCTOBER 2017 AT THE LEVELS INDICATED IN THE RATE TABLES PROVIDED WITHINI THIS ORDINANCE, SAID RATE INCREASES TO AUTOMATICALLY GO INTO EFFECT ON OCTOBER 1, 2014 AND FOR EACH SUBSEQUENT YEAR THEREAFTER THROUGH OCTOBER 2017 UNLESS THE CITY COUNCIL TAKES ACTION TO REVISE THIS ORDINANCE; AUTHORIZING THE MAYOR TO ORDER THE IMPLEMENTATION OF THE AMENDED RATE SCHEDULE WITHIN AND WITHOUT THE CITY; DECLARING A PUBLIC PURPOSE; REPEALING ANY ORDINANCE IN CONFLICT WITH THE MASTER FEE ORDINANCE; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Dilley wishes to amend its natural gas, water and wastewater rate schedule as approved and implemented by Ordinance No.; and

WHEREAS, the governing body of the City has determined the rates for providing municipal utility services requires adjustment in order to reflect its actual costs and to assure the City's continued financial ability to provide these services; and

WHEREAS, the natural gas, water and wastewater systems continue to grow at increased levels each year and the expansion, rehabilitation and improvement needs of existing infrastructure is critical; and

WHEREAS, funding the utility system's capital expansion and improvement plans will require the issuance of revenue and other bonds, the repayment of which will come primarily from the revenues generated by the respective system's user fees and charges; and

WHEREAS, after careful consideration of the financial plan and City Services, the City Council of the City of Dilley, Texas has determined that the public welfare would be best served by amending the Natural Gas, Water and Sewer Fees Schedule,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DILLEY, TEXAS THAT THE FOLLOWING FEE SCHEDULE SHALL APPLY:

NATURAL GAS RATES

- (1) For each defined Customer Class, monthly bills shall be comprised of two components, a minimum charge and a consumption charge.
- (2) Minimum charges will be assessed to all active accounts irrespective of consumption.
- (3) <u>Consumption charges</u> shall be based on metered natural gas consumption converted into "Therms". This conversion shall be calculated each month by multiplying the metered natural gas consumption expressed in CCFs, or hundreds of cubic feet, by the energy factor of the natural gas.
- (4) The energy factor of the natural gas shall be derived from the corresponding monthly statement provided by the City's wholesale natural gas supplier.
- (5) By billing in Therms, Dilley's natural gas customers will pay for the heating value of their natural gas, not the volume of gas used.
- (6) Customers shall be assessed a fuel adjustment charge for each metered Therm. The fuel adjustment charge shall be defined in the wholesale billing statement provided by the City's natural gas provider for the corresponding billing month. The fuel adjustment charge shall be added to the consumption charge for the purpose of calculating the customer's monthly bill. The sum of the customer's minimum charge, consumption charge, and fuel adjustment charge will equal the total amount payable.

(7) The following tables illustrate the scheduled natural gas minimum charge and consumption charge adjustments that will begin on April 1, 2015 and continue every year that follows through April 2018.

Section 2. REPEAL OF CONFLICTING ORDINANCES

This ordinance shall be and is hereby declared to be cumulative of all ordinances of the City of Dilley and this ordinance shall not operate to repeal or affect any such other ordinances except insofar as the provisions there of might be inconsistent or in conflict with the provisions of this Ordinance, in which event such conflicting provisions, if any, in such other ordinance or ordinances are hereby repealed. Regulation in regard to enforcement of the fees herein contained in the various instruments of legislation adopted by the City Council of the City of Dilley, Texas.

Section 3. SEVERABILITY

If any provision, sentence clause, or phrase of this ordinance is determined by a court of competent jurisdiction to be invalid or unconstitutional, such provision, sentence, clause, or phrase shall be severed from remaining portions of the ordinance, which will remain in full force and effect. Any provision, sentence, clause, or phrase of any ordinance currently in effect in the City of Dilley found to be in conflict with any provision, sentence, clause, or phrase of this ordinance is hereby appealed insofar as it is determined to be in conflict.

Section 4. PENALTIES

A person or company who commits a violation of any section or subsection of this ordinance shall be punishable by a fine of not more than one thousand dollars (\$1000.00) for each violation. Each and every day of violation shall constitute a separate offense.

Section 5. PROVIDING AN EFFECTIVE DATE

This ordinance shall become effective immediately upon its passage and approval.
