

# Dilley Public Library DVD & Audio Book Agreement

- 1. Under no circumstances shall any DVD or Audio Book checked out in my name be electronically duplicated or otherwise copied, in part or in whole. Any unauthorized duplication shall automatically cancel this contractual relationship and I will be solely responsible for any legal action regarding the copyright infringement by the Companies Distributor.
- 2. Any DVD or Audio Books checked out in my name will not be used for commercial or theatrical distribution. And will be broadcast or cablecast without prior written consent from the producer.
- 3. Under no circumstances shall any DVD designated for "Home Use Only" or otherwise restricted to private viewing cannot be shown in a public place. According to copyright law, a public performance is one which takes place outside the home or any place where a substantial number of persons outside the normal circle of family and its social acquaintances is gathered.
- 4. I take full responsibility for the determination of appropriate audiences for the content. The audience rating by The Motion Picture Association of America may serve as a general guide.
