

## NOTICE OF PUBLIC HEARING ON PROPOSED TAX RATE

A tax rate of \$0.827540 per \$100 valuation has been proposed by the governing body of City of Dilley.

The no-new-revenue tax rate is the tax rate for the 2025 tax year that will raise the same amount of property tax revenue for City of Dilley from the same properties in both the 2024 tax year and the 2025 tax year.

The voter-approval rate is the highest tax rate that City of Dilley may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is the same as the no-new-revenue tax rate. This means that City of Dilley is proposing to maintain property taxes for the 2025 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 28, 2025 AT 6:30 PM AT DILLEY CITY HALL 116 E. MILLER, DILLEY TX 78017.

The proposed tax rate is greater than the voter-approval tax rate. As a result, City of Dilley is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Dilley City Council of City of Dilley at their offices or by attending the public hearing mentioned above.

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

The following table compares the taxes imposed on the average residence homestead by City of Dilley last year to the taxes proposed to be imposed on the average residence homestead by City of Dilley this year.

| <b>Total tax rate (per \$100 of value)</b> | \$0.801435  | \$0.827540  | increase of \$-0.026, or 3.2% |
| <b>Average homestead taxable value</b>     | \$66,239    | \$72,587    | increase of \$6,348, or 9.5%  |
| <b>Tax on average homestead</b>            | \$530.86    | \$600.69    | increase of \$69.83, or 13%   |
| <b>Total tax levy on all properties</b>    | \$1,449,479 | \$1,456,191 | increase of \$6,712, or 0.04% |
