Discuss/Consider & act on Ordinance No. 25-23-09-B, an ordinance adopting a budget for the ensuing fiscal year beginning October 1, 2025 and ending September 30, 2026 appropriating the various amounts thereof, and repealing all ordinances or parts of ordinances in conflict therewith; and providing for an effective date

8. Discuss/Consider & act on Ordinance No. 25-23-09-C, an ordinance of the City of Dilley, Texas levying an ad valorem tax for the use and benefit of the City of Dilley for the Fiscal year commencing October 1, 2025 and terminating September 30, 2026
