REQUEST FOR RELEASE OF FUNDS

On or about April 7, 2025 the City of Dilley will submit a request to the Texas Department of Agriculture for the release of Community Development Block Grant Program funds under Section 104 of Title I of the Housing and Community Development Act of 1974, as amended, to undertake a project known as water improvements at the Water Plant and Civic Center water well, CDV23-0482 for the purpose of replacing one (1) aerator and expand clear well capacity including all associated appurtenances at the City of Dilley Water Treatment Plant on Avant Street and install one (1) upgraded variable frequency drive to existing pumps, one (1) permanently installed generator, one auto (1) transfer switch, and all associated appurtenances at the Civic Center Water Well facility on Main Street, and associated administration and/or engineering activities, for an estimated cost of \$500,000.00 in HUD funds and \$25,000.00 in non-HUD funds. The project is located as follows: City of Dilley Water Treatment Plant Avant Street and Civic Center Water Well on Main Street. If funds allow, the project will include no additional activities.

FINDING OF NO SIGNIFICANT IMPACT

The City of Dilley has determined that the project will have no significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. Additional project information is contained in the Environmental Review Record (ERR) on file 116 E. Miller Street Dilley Texas 78017 and may be examined or copied on weekdays at 8:00 AM to 5:00 P M.

PUBLIC COMMENTS

Any individual, group, or agency may submit written comments on the ERR to the Office of the City Manager at cityadministrator@cityofdilleytx.com. All comments received by April 4, 2025 will be considered by the City of Dilley prior to authorizing submission of a request for release of funds.

Comments should specify which Notice they are addressing.

ENVIRONMENTAL CERTIFICATION

The City of Dilley certifies to the State of Texas that Henry Arredondo in his capacity as City Manager consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. The State's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows the City of Dilley to use Program funds.

OBJECTIONS TO RELEASE OF FUNDS

The State will accept objections to its release of funds and the City of Dilley's certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the City of Dilley (b) the City of Dilley has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by the State; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to Texas Department of Agriculture at CDBG_EnvReview@TexasAgriculture.gov or PO Box 12847, Austin, Texas 78711. Potential objectors should contact the State to verify the actual last day of the objection period.
